# VISIT TO JAPAN

Both the communists and the socialists in Japan, and elsewhere, are doing their utmost to spoil President Eisenhower's visit to Tokyo. After the recent reception given to Press Secretary Mr. Hagerty it is clear that President Eisenhower will run risks in going ahead with his plans.

The consequences of cancelling that visit would be serious. The Security Treaty between America and Japan, which has been used as a pretext for demonstrations against the Kishi Government, has been strongly attacked by both Moscow and Peking. To bow before the communist is storm would be equal to appearement, which would have repercussions throughout Asia.

It should be made clear that the Treaty was an issue at the Japanese elections last year. Mr. Kishi won: the Treaty was freely negotiated by a legitimate government. The Opposition, having failed to make its will prevail in a democratic fashion, has now resorted to violence.

To give in to violence at this stage would be to invite greater violence in the future. President Eisenhower, therefore, is displaying courage and wisdom in going ahead with his visit. It is also possible that the Opposition tactics may result in a strong revulsion among the majority in Japan which in turn may strengthen relations between that nation and the U.S.A.

They are not told from which source the money will be coming nor on what conditions. They are not told who is to give employment to the many thousands now earning their May, living with the Three Services.

Direct and indirect aid from Britain to Malta is in the region of £30,000,000 each year. Who or what is going to replace that amount each year? Will Nasser provide it? Or that Tito? or Bourguiba?

The socialists have got themselves into a position from which it is hard to go back: equally they cannot go forward. The whole policy and the entire outlook are negative and destructive.

Fortunately the bulk of the population have refused to respond to threats or appeals not to cooperate with the present Administration or with Baileys, and not to play a part in the tourist drive or in the projected industrialization of

Time and time again the people who use the loud speakers have been shown that they cannot lead from the public squares. Noisy demonstrations and bellicose speeches can only impress the gullible and the emotional. They do not and cannot transform facts.

The majority in Malta and Gozo refuse to commit economic suicide. They will refuse to follow the Malta Labour Party so long as the leadership persist in a line of thought and policy which offers no future and holds no promise except of sacrifice, distress and despair.
